Compliance with Regulation (EC) n. 1907/2006

This declaration aims to inform you concerning the compliance with the provisions laid down by Regulation (EC) No 1907/2006 concerning Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH).

As you may be aware, according to REACH Regulation, any manufacturer or importer of a substance either on its own or as component of one or more mixtures in quantities equal to or greater than one tonne per year, shall submit a registration to the Agency (ECHA - European Chemicals Agency).
