



REACH

In accordance with art.33 of Reg.1907/2006, we confirm that our articles, produced after 01st January 2007, do not contain any SVHC substances, included in the latest updated Candidate List, in concentration more than 0.1% weight by weight.

The "Candidate List" will be regularly updated when more substances are identified as SVHC, so we will notify you of any change concerning our raw materials status and we will eventually suggest possible alternative solutions.
